

# Formation of the Association 1951

May 13, 1952

To: All Land Owners and Residents of the Six Ponds' Area Plymouth County Massachusetts

Subject: Proposal For Formation Of A Non-Profit Voluntary
Organization To Be Called - "THE SIX PONDS IMPROVEMENT
ASSOCIATION".

On September 3, 1951, the following persons met informally to discuss the formation of the above Association, viz: Mrs. Ernest Basset, Mrs. Edward Bement, Mrs. Gilbert Besse, Mrs. Schuyler Chapin, Mr. Richard Conant, Dr. T. V. Corsini, Mr. Roger Dunscombe, Mrs. E. S. Emery, Jr., Mrs. Langdon Geer, Mrs. Lawrence Howe, Mrs. Julian Kelley, Mrs. Lewis D. Mowry, Mr. and Mrs. Parker Pond, Mrs. Frank Probst, Mrs. Elmer Raymond, Mr. and Mrs. William Stearns, Jr., Mrs. Frederick Steinway, Mrs. Theodore Steinway and Mr. Maxwell Van Buskirk.

It was voted to establish such an Association. It was the sense of the meeting that the Association should be concerned with the matters listed in Article II of the proposed Articles of Association.

To effectuate the foregoing a Committee was appointed to establish the framework of a permanent organization, and the following named persons were requested to serve on the Committee, viz: Mrs. Gilbert Besse, Mr. LeBaron Briggs, Mrs. E. S. Emery, Jr., Mr. H. S. Goodhue, Mr. Parker Pond, Mr. Elmer Raymond and Mr. William Stearns, Jr., Chairman.

This Committee has elected Mr. Stearns as Chairman and Treasurer, and Mr. Goodhue as Secretary. The Committee now recommends that a meeting of all interested persons be held at eleven o'clock A.M. on the Fifth of July, 1952, at Mrs. Lawrence Howe's Hall, East Long Pond Rd., Long Pond, to vote on the establishment of "THE SIX PONDS IMPROVEMENT ASSOCIATION". The Committee further recommends, in the event such an Association be established, that Articles of Association similar to the enclosed, be adopted.

At the coming meeting on the Fifth of July we intend to propose that the enclosed Articles be adopted, thus forming the Association officially. We believe that the meeting should consider establishing certain Standing Committees, and we hope that volunteers will come forward to serve on such Committees as are adopted. For example, the following might be considered:

- (1) Road Committee
- (2) Health Committee
- (3) Fire Hazard Committee
- (4) Water and Life Saving Committee

### **Article II Purposes**

- The Association shall concern itself with the following matters pertaining to the Six Ponds Area.
  - a) Building Laws, Zoning Laws and Permits:
  - b) Road Maintenance, road signs and traffic control;
  - c) Health, water, Safety and Sanitation;
  - d) Fire and Regulations;
  - e) Matters and activities affecting the comfort and quiet enjoyment of the property and property rights;
  - f) Collection and dissemination of information to all members concerning any matter affecting the Six Ponds area; and
  - g) Such group or community measures as may, from time to time, be for the benefit of the Six Ponds area; and
  - h) Representation of the Association before any agency, body, authority or commission of the Commonwealth, or any town or county, when matters affecting the area are under consideration, said representation in no way to limit any action by any individual or Member of the Association.


#### Six Ponds 2018 Monitoring Results
